

# Eden Jazz Fest

## **Mission Statement:**

Preserve, promote, and perpetuate the tradition of Jazz. Increase accessibility for live performances of original jazz works and arrangements. Provide musical education and performance opportunities for the youth in North Carolina.

## **Purpose:**

The purpose of the festival is to be a fundraiser for the music educational program in the Rockingham County school system. The specific goal is to raise funds for private lessons for students to be given by professionals whose disciplines correlate with the specific instruments played by each student. In other words, a brass teacher would teach brass instruments, a woodwind teacher would teach woodwinds and a percussion teacher would teach percussion. The professional instructors will coordinate with the band directors' curriculum and objectives. This program would make sure that students in general would not lack the basic and correct fundamentals of playing their instruments and reading music. Also, the band directors, who are doing a great job, will not be faced with the unrealistic task of teaching an entire band how to play all their various instruments and at the same time to perform the necessary performance pieces. The private lessons will build confidence, bring students closer to their potential, raise the performance level of ensembles and prepare those who will seek a music degree at a college.
